a. Adoption of Tentative Millage for Fiscal 2019- Resolution 18-26

President Whitten asked the City Clerk to read Resolution 18-26 by title.

The City Clerk read, "Resolution 18-26 by title:

RESOLUTION 18-26

A RESOLUTION OF THE CITY OF CRESTVIEW OF OKALOOSA COUNTY, FLORIDA, ADOPTING THE TENTATIVE LEVYING OF A MILLAGE OF 6.9466 FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019; PROVIDING FOR AN EFFECTIVE DATE.

This is Resolution 18-26."

Ms. Roy, City Clerk stated that the purpose of the Public Hearing is for the adoption of the Tentative Millage rate for the Fiscal year 2019. Last fiscal year the millage rate was adopted at 6.9466 and that is the current rate that it's being proposed for 2019.

A RESOLUTION OF THE CITY OF CRESTVIEW OF OKALOOSA COUNTY, FLORIDA, ADOPTING THE TENTATIVE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019; PROVIDING FOR AN EFFECTIVE DATE.

This is Resolution 18-27."

Ms. Roy, City Clerk this budget for 2019 is \$37,511,472.00.

President Whitten asked Council for action.



Vice President Cox closed the Public Hearing.


